Child Trafficking Prevention Education Curriculum Overview

1. In an effort to build resiliency among our youth and to foster safe environments conducive to student learning the Jackson County School District will require that all students in Grades 6-12 complete instruction each year with regards to Child Trafficking prevention and awareness. The curriculum will include the following components as required by the State Board of Education Rule 6A-1.094121, F.A.C and Rule 6A-1.094123, F.A.C:
 - A. Recognition of signs and symptoms of mental health disorders
 - B. Prevention of mental health disorders
 - C. Mental health awareness and assistance
 - D. How to reduce the stigma around mental health disorders
 - E. Awareness of resources, including local school and community resources
 - F. The process for accessing treatment
 - G. Strategies to develop healthy coping techniques
 - H. Strategies to support a peer, friend, or family member with a mental health disorder
 - I. Prevention of suicide
 - J. Prevention of the abuse of and addiction to alcohol, nicotine, and drugs
 - K. Human Trafficking, Keeping Yourself Safe and Sex Education

Instructional Delivery

The Child Trafficking prevention and awareness curriculum will be delivered in an online internet based comprehensive Child Trafficking prevention and awareness program through Edgenuity in cooperation with Purpose Prep. The curriculum meets the ruling beyond the minimum requirement of instruction with course specification per grade that is developmentally appropriate. Instruction will be delivered in the following courses:

*Students in upper grade levels taking dual enrollment/early admit courses will still be required to complete the Child Trafficking prevention and awareness curriculum requirements via our online internet based comprehensive Child Trafficking prevention and awareness program through Edgenuity in cooperation with Purpose Prep.

Professional Qualifications

1. The instructors designated to assist with the Jackson County School District Child Trafficking prevention and awareness curriculum are provided through the online internet based comprehensive mental health program instruction through Edgenuity in cooperation with Purpose Prep. The list of Purpose Prep/Edgenuity instructors for each instructional segment is attached.

2. Oversight and implementation of the Child Trafficking prevention and awareness curriculum will be conducted by the Director of Transportation, Health, and Safety and the Lead Mental Health Counselor for Jackson County School District. The combined qualifications of the two staff are as follows:
 - A. Certified School Safety Specialist
 - B. Fortify FL Administrator
 - C. Youth Mental Health First Aid Trainer
 - D. Threat Assessment Trainer (Dewey Cornell Model)

Materials and Resources

1. The Jackson County School District has chosen to partner with an online internet based comprehensive Child Trafficking prevention and awareness program through Edgenuity in cooperation with Purpose Prep. The curriculum meets the ruling requirement of instruction with Child Trafficking prevention and awareness course specification per grade that is developmentally appropriate and skill building, which advances each year with student progression.

Data Tracking & Reporting

1. The Director of Transportation, Health, and Safety and the Lead Mental Health Counselor for Jackson County School District will provide a report to the Commissioner of Education by July 1st of each year verifying completion of instruction.
2. The Director of Transportation, Health, and Safety and the Lead Mental Health Counselor for Jackson County School District will monitor completion of the online internet based comprehensive Child Trafficking prevention and awareness Edgenuity/Purpose Prep curriculum for all 6th through 12th grade students. Individualized tracking of student progress through the modules and completion of instruction will be accomplished through the individualized progressive tracking of module completion within the online platform.
